

# Starlight Investments Announces Two Milestone Development Projects in Greater Toronto Area



Toronto – **November 8, 2018** – Starlight Investments (“Starlight”) is pleased to announce that it has broken ground on two new development projects located at 155 Wellesley Street East in Toronto and 2475 Hurontario Street in Mississauga.

The development project at 155 Wellesley Street East, a concrete medical office/retail project in the Church and Wellesley neighbourhood, is a two storey modern podium featuring an environmentally sustainable roof. The development will increase the total square footage by 26,072 (24,118 square feet of office area and 1,954 square feet of retail). The project will also include upgrades to the existing eighteen-storey high-rise apartment building and upgrades to street frontage, curb appeal and landscaping, all of which will increase pedestrian security and improve the community.

The 2475 Hurontario Street development project is the first mid-rise apartment building to be developed in Starlight’s portfolio and is also the first development project of seven in the City of Mississauga. The six-storey property will be comprised of 80 bachelor, one and two bedroom units and will compliment the existing high-rise building at 2465 Hurontario Street, Mississauga. Building finishes and amenities are condominium quality and include a high-end fitness centre and yoga studio, billiards lounge, and a spacious roof top terrace.
