



**True North Commercial Real Estate Investment Trust
Commences Deployment of July 2018 Unit Offering with
Strategic Property Acquisition in Abbotsford, British Columbia**

TORONTO, July 23, 2018 – True North Commercial Real Estate Investment Trust (TSX: TNT.UN) (the "REIT") is pleased to announce it has agreed to acquire a 52,000 square foot office property located at 32071 South Fraser Way, Abbotsford, British Columbia (the "**Abbotsford Property**").

"This is the first of seven potential properties to be acquired using the proceeds from the July 2018 public unit offering," said Daniel Drimmer, the REIT's President and Chief Executive Officer. "This acquisition is in-line with the REIT's core strategy of growing its portfolio with a high quality office building in an urban market, 100% occupied by a credit-rated tenant."

The purchase price for the Abbotsford Property is approximately \$22.0 million, exclusive of closing costs, and is expected to be satisfied by the proceeds from the REIT's July 2018 public unit offering, and first mortgage financing on the property in the amount of approximately \$14.25 million, with an estimated annual interest rate of approximately 3.75% for a 5 year term.

Closing is expected to be on or about August 30, 2018.

Abbotsford Property

The Abbotsford Property is a six-storey office building situated on 1.64 acres of land with 52,000 rentable square feet and 173 parking stalls. The property is located in the heart of Abbotsford's commercial node with easy access via major roadways, highways and public transit. With an average remaining lease term of 6.4 years, the building is 100% occupied by a single credit-rated tenant.

Update on Potential Property Acquisitions

As previously announced, the REIT had entered into an agreement of purchase and sale with respect to a 27,000 square foot office property located in Victoria, British Columbia and has now successfully executed agreements of purchase and sale for the remaining five properties. Key metrics of the six potential acquisition properties (the "**Potential Acquisition Properties**") are as follows:

The acquisition of the Potential Acquisition Properties remains subject to, among other things, satisfactory completion of standard due diligence by the REIT.

The REIT currently owns and operates a portfolio of 41 commercial properties consisting of approximately 3.3 million square feet in urban and select strategic secondary markets across Canada. The REIT is focused on growing its portfolio principally through acquisitions across Canada and such other jurisdictions where opportunities exist.
