Starlight Hybrid Global Real Assets Trust Announces Private Placement

TORONTO, May 6, 2019 – Starlight Investments Capital LP ("Starlight Capital" or the "Investment Manager") is pleased to announce that Starlight Hybrid Global Real Assets Trust (the "Trust") (NEO: SCHG.UN) intends to complete a non-brokered private placement of Series C units of the Trust ("Series C Units") for gross proceeds of up to \$20,000,000 (the "Offering").

The offer price ("Offer Price") of each Series C Units will be equal to the net asset value ("NAV") per Series C Unit on the pricing date ("Pricing Date"), plus costs. The NAV per Series C Unit will be calculated on the Pricing Date which is expected to be on May 31, 2019. For reference purposes, the Offer Price on April 30, 2019 would have been \$10.19 plus costs per Series C Unit.

Subject to customary closing conditions, including the approval of the Aequitas NEO Exchange, the Offering is expected to close on or about June 28, 2019. The securities issued in connection with the Offering will be subject to a four month hold period, in accordance with applicable securities laws.

The net proceeds of the Offering will be used to purchase securities for the Trust's portfolio in accordance with the Trust's investment objectives and investment strategy and for general operating purposes.
